### GENERAL

The **2011 Chief Tuscaloosa Regional** will be held at *The Jim Collins Shooting Sports Facility* at Moundville, Alabama. This match will be an NRA Sanctioned Registered Regional Match. It will be an outdoor three gun 2700 pistol match (.22 cal., CF, and .45 cal) with Team Match scores from individual National Match Course Scores, a Distinguished Revolver Match and an Excellence in Competition Match. This tournament is open to all competitors.

### ENTRY FEES

A package fee of \$60.00 will be charged for the 2700 aggregate. Individual matches will be \$10.00 per match. A Distinguished Revolver Match, and Distinguished Service Pistol (Excellence In Competition) Match will be fired and the costs per match are \$10.00. A package fee of \$70.00 will be accepted for all individual competitions. Team fees are \$ 10.00 per team for the team aggregate. The package for Juniors is \$30.00 for the 2700 and \$40 if including either or both the EIC and Distinguished Revolver Matches.

### RANGE

**The Tuscaloosa Gun Club's** range, *The Jim Collins Shooting Sports Facility*, is located three miles South of Moundville, Alabama. From the traffic light (not the blinking yellow light) on AL 69 in Moundville, go South 3.2 miles, the entrance is on the left (East) side of the highway and is also a driveway beside a white house. Proceed past the residence, and go through the gate into the range. If you are coming from the South then you are traveling North on AL 69, from the blinking light at Hale Co Rd 64, go .7 miles and turn right into the driveway at the white house and go through the gate into the range.

### SAFETY AND MEDICAL

**All firearms safety practices will be strictly observed.** Failure to obey safety rules is cause for disqualification. Any medical emergency should be reported to the Match Director immediately.

## **ACCOMMODATIONS & TRAVEL**

All expenses and reservations for lodging, travel to and from this competition, local transportation, etc. are the responsibility of the competitor. Numerous motels and hotels in the Tuscaloosa Area are available and are located at the intersections of I-59 and I-359 and Alabama Highway 69. Jamison Inn, 205-345-5024, and Fairfield Inn, 205-366-0900 are the closest, but others are in close proximity to them. ## **CATEGORIES/CLASSIFICATION**

All Competitors will compete in the OPEN category in their NRA Classification.

## **RULES**

Current NRA Conventional Pistol Rules govern this competition. The Current Edition of CMP Rules governs the EIC match. Special circumstances may require the issuance of modifications to firing conditions. Match Director's Bulletins will be posted at the Range of any modifications.

## **COMPETITORS RESPONSIBILITY**

It is the competitor's responsibility to fire the prescribed number of shots on the correct targets. Penalties will be assessed according to the current NRA Pistol Rules. It shall be the competitor's responsibility to immediately inform the range officer of any hits on incorrect targets. **Competitors firing the Excellence in Competition or Distinguished Revolver are responsible for providing the service ammunition prescribed for those matches.**

## **TARGETS**

All shots will be fired on Official NRA paper targets only.

## **SCORING CHALLENGES**

Challenges must be made immediately upon scoring. All scoring will be conducted per the current NRA Pistol Rules. Any administrative challenge must be made within the posted challenge time (within ten minutes of posting). A challenge fee of \$2.00 will be charged to all competitors making challenges.

## **AWARDS**

Awards will be presented to the **Match Winner, Match Runner-Up** as well as to the high scores in the following classifications: **High Master, Master, Expert, Sharpshooter, Marksman, and Unclassified.** The CMP will award place medals and points accordingly.

## **SCHEDULE**

All Matches will commence promptly at 9:00 AM CDT.

Saturday: Relay #1 will fire the .22 Match at 9:00 AM and Relay #2 will fire the .22 Match immediately thereafter. Relay #1 will fire the CF Match as soon as Relay #2 completes the .22 Match. Relay #2 will then fire the CF Match when Relay #1 completes the CF Match.

Sunday: Relay #1 will fire the .45 Match at 9:00 AM and Relay #2 will fire the .45 Match immediately thereafter. The Distinguished Revolver Match and the Excellence in Competition Matches will then be fired simultaneously and there will be at least two relays fired to allow all competitors the opportunity to fire in both matches.

## **COURSES OF FIRE**

Match #135 – .22 cal. Slow Fire Match - 20 shots slow fire, 2 strings of 10 rounds, 10 minutes per string

Match #136 – .22 cal. National Match Course - 30 shots, 10 rounds slow fire, 10 rounds timed fire, and 10 rounds rapid fire

Match #137 – .22 cal. Timed Fire Match - 20 shots timed fire, 4 strings of 5 rounds, 20 seconds per 5 shot string

Match #138 – .22 cal. Rapid Fire Match - 20 shots rapid fire, 4 strings of 5 rounds, 10 seconds per 5 shot string

Match #101 – .22 cal. Championship - 90 shot aggregate

Match #139 – CF Slow Fire Match - 20 shots slow fire, 2 strings of 10 rounds, 10 minutes per string

Match #140 – CF National Match Course - 30 shots, 10 rounds slow fire, 10 rounds timed fire, and 10 rounds rapid fire

Match #141 – CF Timed Fire Match - 20 shots timed fire, 4 strings of 5 rounds, 20 seconds per 5 shot string

Match #142 – CF Rapid Fire Match - 20 shots rapid fire, 4 strings of 5 rounds, 10 seconds per 5 shot string

Match #102 – CF Championship - 90 shot aggregate

Match #143 – .45 cal. Slow Fire Match - 20 shots slow fire, 2 strings of 10 rounds, 10 minutes per string

Match #144 – .45 cal. National Match Course - 30 shots, 10 rounds slow fire, 10 rounds timed fire, and 10 rounds rapid fire

Match #145 – .45 cal. Timed Fire Match - 20 shots timed fire, 4 strings of 5 rounds, 20 seconds per 5 shot string

Match #146 – .45 cal. Rapid Fire Match - 20 shots rapid fire, 4 strings of 5 rounds, 10 seconds per 5 shot string

Match #103 – .45 cal. Championship - 90 shot aggregate

Match #100 – Match Championship - 2700 aggregate
